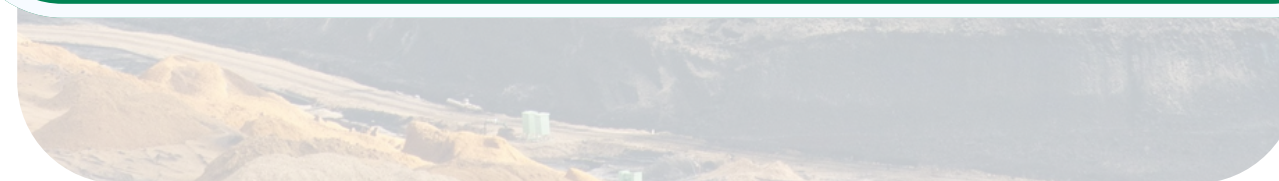
### **INFRASTRUCTURE**
